Annual General Meeting – 11th March 2023

Annual General Meeting of Swim England North West Limited, Hybrid meeting held at Holiday Inn Express, Leigh, on Saturday 11th March 2023, commencing at 10.45 hours.

1.23 Welcome and Introductions by the Chair

1.1 The chairman opened the 2023 AGM of SENW Ltd meeting at 10.45 hours by welcoming everyone to the meeting, DB and attendees observed a one minute silence in memory of David Collins and Gordon Dacre.

- Finance Report Helen Whittle apologised and advised the finance report hasn't yet been distributed as the accounts are still with auditors due to the timing of year end and the AGM, HW advised for information only the pre audit loss for 2022 was £10,000 this may change when accounts finalised, currently have £300,000 in bank, HW has meeting with auditors on 20th March 2023 and hopefully accounts can be distributed first or second week in April following meeting with auditors reports will be circulated to all members once received.

Simon Rothwell proposed the board be authorised to sign off the accounts Jim Wilks second the proposal. Keith Chisholm advised that is was anticipated that because the AGM was early the accounts may have not been available and within the Articles of Association of the company there is a facility for the Directors to send out the financial accounts at a later date once audited to the members of the company, the approval has to then be done by a director of the company once accounts audited, KC advised only voting on the Annual report and not the Financial accounts - Annual report accepted.

- Simon Rothwell asked in the light of recent items in the news what actions has the SENW board taken to censure Swim England over the abject failure to oversee and manage a judicial system and child protection and safeguarding within the association, DB advised that the board have appointed a new welfare officer with a vast amount of experience, all directors and counties are being invited to attend the Swim England safeguarding course of which the region are funding, with regards to censoring Swim England as the report has only just come out at present the directors haven't had chance to discuss, SR advised he hadn't seen the new report that Sport England have published but findings of the independent report stated that one of big issues they criticized was that clubs were required to appoint welfare officers whom had no experience and even after training this wasn't sufficient and should be a professional, DB advised the region have a professional Welfare officer whom is very experienced, with regards to Swim England it was discussed at the last chairs meeting that this is something they are now looking in to in light of the report, Swim England will have to submit a report by the end of the month.
- James Collins asked the board to enhance the training available that the region offer (L1, L2, Team Manager 1&2, Safeguarding) as we have funds available to put these courses on, DB advised all the courses mentioned are circulated every week to all club committee members with all the courses available, the Regional office co-ordinator also advised they are available on website posted on social media emailed to club secretary's and all committee members each week and in the and in monthly newsletter, DB advised club officer will be visiting clubs and will promote, DB advised at this current time we have limited tutors available to deliver the courses, tutors they are selected by Swim England and have to apply directly with them. Bob Bolton advised the prerequisite of being a tutor is you have to have an educational qualification this can add a year on to the training of a new tutor, most regions are struggling for tutors, Sue Robinson has sent workforce survey to all clubs for requirements for next year.

Swim England introduced and updated the process required for clubs needing to achieve SwimMark or Club Affiliation. With the support of the regional staff, our Regional Club Development Officers continue to work hard encouraging clubs to achieve these standards.

It is with great sadness we acknowledge the commitment and dedication given to the region by two respected stalwarts who passed away during 2022. In August we celebrated the service given by Gordon Dacre, he raised the profile of Water Polo both within the region and nationally this is part of his legacy to the sport. In December we celebrated David Collins, he was a well-respected official, club officer, and an advocate for good governance supporting many clubs over the years.

In May Jim Wilks became the new President of Swim England. This is a great honour not only for Jim and the Region. I am sure he must have been extremely proud as we are to see so many of our athletes taking part in the Commonwealth Games in Birmingham.
