The consideration times have been generated from the swimming results rankings for the North West Region Times have been generated from 'Swim England Rankings' taking a time from approximately 16th place for 15/16, 16/Under & 17/Over Age Groups and 8th place for 14/Under Age Group for development swimmers and checked by the Events Team. Entry Information

In line with the Swim England Transgender and non-binary competition policy, please see information on the definition of categories:

Female – Athletes with a birth sex of female.

Open – Athletes with a birth sex of male, trans or non-binary competitors and any competitor not eligible for the female category.

The Championship Manager has the authority to adjust the number of entries accepted to ensure the efficient running of the Championships.

Competitors are responsible for checking their entries carefully. Any questions should be forwarded to events@swimnorthwest.org immediately.

Accreditation

All Clubs are required to ensure that they comply with the Swim England Team Manager, Coach and Chaperone Policy.

All coaches, chaperones and team staff must have a valid accreditation to access the event. Accreditation is non-transferable and must be worn at all time when inside the venue.

It is the clubs' responsibility to ensure that individuals who carry out a Supervisory Role are listed on the Club Personnel Report and have the appropriate qualifications in place as per the above policy:

- Valid and in Date DBS
- Valid and in Date Safeguarding
- Level2 Coaching Qualification (Minimum Level 1 Coaching Qualification) or Team Manager Module 1

Coaches; Team Managers and Chaperones requiring access to poolside must purchase a pass in advance using the online system. Accreditation will be emailed to you in PDF format to print and bring to the event.

Coaches, Team Managers and Support Staff will be required to sign into every session and provide evidence of their Coaches Pass.

Information

The Championship Entries Manager has the authority to adjust the number of entries accepted to ensure the event is compliant with Swim England licensing requirements.

Competitor Information

Session Times

Warm up and session start times will be provided on **Wednesday 29th October 2025**.

The swim down pool will be made available throughout the competition.

Between Sessions

Competition Pool closes from the end of the competition session to the commencement of warm up.

Starts

The event may be conducted using over the top starts and in water backstroke starts. When Swimmers have completed their race they must remain close to the end of the pool and hold onto the lane rope. They shall clear the pool immediately the next race has started.

Streaming and photography

There will be **NO Live Streaming and photography** taking place at this event.

Spectator Information

Spectator Tickets will need to be purchased prior to the sessions.

Cost of tickets:

CARD ONLY at the Spectator Entrance

- £6.00 per spectator for a single sessions
- £10 per spectator for the full day

Competition Refund Policy

Swim England North West policy relating to entry refunds is as follows.

All criteria outlined below must be submitted within 5 days of the completion of the event.

Following this 5-day period, and subject to all criteria outlined below being adhered to refunds will be processed within 28 days.

Rejection from Events

If entries have been rejected by the Championship Manager where conditions were adhered to but rejection is based on time constraints, then refunds will be automatically processed for each rejected event following the completion of the competition.

Rejection due to non-compliance of conditions

Any entries rejected due to non-compliance of competition conditions will not be refunded. By entering any Swim England North West Event or Competition, individuals are committed to adhering to all conditions and policies outline by Swim England North West.

Withdrawal due to exceptional circumstances (e.g. Medical or Injury)

Individuals who have withdrawn from events due to either a medical reason or injury – refund will be considered by application and submission of appropriate evidence (e.g. note from doctor or note from physio). Supporting evidence must be sent to events@swimnorthwest.org

Withdrawing from the event must be completed 60 minutes prior to the session in which the individual is due to compete. Any failure to withdraw or notification of withdrawal received later than the event withdrawal cut off time will result in no refund being processed.

Following the completion of the event, please submit details within 5 days and email events@swimnorthwest.org

In line with the Swim England North West Data Protection policy, once the refund has been processed, documents relating to an individual's medical information will be destroyed.

Withdrawals

Withdrawals from heats must be submitted electronically online using the [online entry viewer](#).

Withdrawals from finals must be submitted using the advertised procedure.

For all withdrawals which would not be considered under the heading above, refunds will not be processed.

Exceptions to the above may be considered by the Event Management Group but these will be dealt with on a case by case basis. Withdrawals prior to the event can be sent to events@swimnorthwest.org
